Improving Prisoner Reentry Services Through Faith-Based Partnerships

Each year hundreds of thousands of inmates are released from Federal and State prisons to be reunited with their communities and families. Community service intervention is critical to this group to avoid potential relapse back into criminal activity. According to the U.S. Department of Justice Bureau of Justice Statistics, two out of three formerly incarcerated individuals are likely to be re -arrested for new crimes

within three years of their release from prison and more than half will be re-incarcerated.

Numerous challenges contribute to their return to criminal activity, re-arrest and/or re-incarceration. Some of these challenges include joblessness, substance abuse, mental health problems, low levels of educational attainment, lack of stable housing and poor family connections.

It's often the faith-based institutions that provide the bridge between the returning offender and family. Many offer the basic survivor services (food, clothing, shelter) as well as mentoring, coaching, training/skill development, and an influential connection to the business community. They can also influence the community's attitudes toward those with a criminal background.

Pastors Ronald and Marjorie Sharpe and the Powerhouse Church of Jesus Christ congregation have been a strong influence within the community for many years and provide outreach services far beyond the walls of the church. Powerhouse supports many community organizations by providing food to the poor, tutoring area youth, and mentoring.

One bit of advice that he gives to other CSI participants is -----"One of the biggest things you need is a plan. Have a long term and <u>short term goal</u>. Once you have set the long term goals, achieve the short term goals. Get your credit score; see what you have to do to bring it up to speed."

Although his days are full: working (when the opportunity arises) and attending training, Chris still finds time to volunteer and give back to the community. He is a CSI volunteer and is frequently known to tell other CSI participants, "If I can do it...And I did it.... The field is wide open...all you got to do is show forth the initiative that you have got it. You can't allow your past to dictate your future."

On April 9, 2008 the Second Chance Act was signed into law and designed to improve outcomes for people returning to communities from prisons and jails. This legislation is first-ofits-kind and authorizes federal grants to government agencies and nonprofit organizations to provide employment assistance, substance abuse treatment, housing, family programming, mentoring, victims support, and other services that can help reduce recidivism.


These grants offer funding to programs which emphasize collaboration between government agencies, nonprofits, community programs, and other organizations. Through this legislation the Federal Government has finally caught up with what we as community activist have come to realize for years; in order to provide a comprehensive effort, organizations, both public and private, must work together in order to maximize results in helping reduce recidivism.


This year's Second Chance grant opportunity highlights funding to help create and sustain quality programs that address these efforts in the area of probation. The "Smart Probation: Reducing Prison Populations, Saving Money, and Creating Safer Communities FY 2012 Competitive Grant Announcement" was announced on March 22, 2012, and is designed to address new and innovative probation programs that collaborate with outside reentry efforts to assist those most highly likely to continue through the revolving doors of the prison system. This grant is significant in helping to reduce recidivism because of its attention to providing funding to programs that not only utilize best practice efforts, but also take a new approach to probation by helping to join wrap around services to probation provisions for a more complete assistance for those reentering the community from the prison system.


While the grant is only open to states, units of local government, and federally recognized Indian tribal governments it is important that local agencies reach out to their government officials to work with them in obtaining these funding sources and others similar.

Did You Know ?

Fact: Employers can save money on their federal income taxes in the form of a tax credit incentive through the Work Opportunity Tax Credit (WOTC) program by hiring formerly incarcerated individuals . The hiring date must be within one year from the date of conviction or release from prison.

Fact: An eligible Veteran, who is not currently incarcerated, can use VA care regardless of any criminal history, including incarceration. Only when an otherwise eligible Veteran is currently incarcerated, or in fugitive felon status, is he/she not able to use VA health care.

Fact: Veterans may inform VA to have their benefits resumed within 30 days or less of their anticipated release date based on official prison documentation showing the scheduled release date.

Fact: States are not required to terminate eligibility for individuals who are incarcerated based solely on inmate status. States may suspend eligibility during incarceration, enabling an individual to remain enrolled in the state Medicaid program, thereby facilitating access to Medicaid services following release. Assistance Program) benefits even if he/she does not have a mailing address.

Fact: Most states have eliminated or amended the ban to allow convicted drug felons to receive SNAP benefits. North Carolina is one of the states that has amended the ban to allow individuals to regain eligibility by meeting certain additional requirements, like receiving or completing drug or alcohol treatment.

Fact: Individuals who are currently incarcerated in a federal, state, or local correctional institution have some limited eligibility for federal student aid. In general, restrictions on federal student and eligibility are removed for formerly incarcerated individuals, including those on probation, on parole, or residing in a halfway house.

Fact: Social Security benefits are not payable if an individual is convicted of a criminal offense and confined. However, monthly benefits usually can be reinstated after a period of incarceration by contacting Social Security and providing proof of release.

Fact: A person can get SNAP (Supplemental Nutrition
